JCI-accredited Organizations Shine at IFQSH London

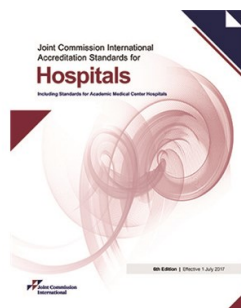

New 6th Edition JCI Hospital Manual Goes into Effect Soon



The new 6th edition of the JCI Accreditation Standards for Hospitals manual is now available in both hard copy and electronic formats. Click [here](#) to order your copy.

The effective date of the new hospital manual is 1 July 2017, which means all hospital and academic medical center surveys that begin on or after this date will utilize this new set of standards. The 6th edition includes a detailed summary of the major changes between the 5th and 6th editions (see "Summary of Changes to the Manual" near the beginning of the book) and other user-friendly features.

Currently, the 6th edition is available in [English](#) and [Chinese](#) only. Additional translations are planned in Spanish, Portuguese, and Italian in 2017. See the JCI website for availability and pricing.
