



## 6th Edition In-Depth: **Staff Health and Safety – Second Victim**

*Each month we highlight a section of the new 6th edition hospital standards. This series of articles provides a closer look at areas of concern for JCI-accredited hospitals and any health care organization focused on patient safety and quality improvement.*

**Standards SQE.8.2:** *The hospital provides a staff health and safety program that addresses staff physical and mental health and safe working conditions.*

The health care environment is fast-paced, frequently changing, and can be very stressful. Care givers are often faced with many difficult situations that can be both emotionally and physically challenging. Despite health care organizations and health care practitioners working hard to improve the safety of patient care, adverse and sentinel events continue to occur. When a patient suffers an adverse event, many people are affected — the patient, his or her family, and the health care practitioner. The patient's and family's needs become the priority for the health care organization, however the health care practitioner most directly involved in the event may be emotionally traumatized and experience effects that may last for months or even years. The health care practitioner becomes the “second victim” of the adverse or sentinel event.

JCI's 4th Edition of the Ambulatory Care Standards is planned for publication on 1 January 2019 with an effective date of 1 July 2019. As part of the development of a new edition of the standards manual, focus groups are conducted with participants from Joint Commission International (JCI) accredited health care organizations.



Focus group participants are asked specific questions that are designed to encourage candid, open discussion of opinions with other participants.
